Collegio Don Nicola Mazza is a University College of Merit accredited by the Italian Ministry of University and Research (MUR). With its activities, it upholds the constitutional right (Constitution of the Italian Republic, Article 34 – Right to Education) by providing capable and deserving students – even if economically disadvantaged – with the opportunity to achieve the highest levels of education.

Therefore, even the economic or socio-cultural conditions of deserving applicants are taken into consideration during the selection process and admission to Collegio Mazza provides for economic benefits to students in particular situations and/or with specific needs that might preclude access to a valuable college experience.

**Aptitude for personal growth**

While the selection process takes into account scholastic and academic achievements, it also explores the aptitude of applicants to express their full potential through a 360-degree growth that encompasses all dimensions of a person.

**Aptitude for relationships and sharing**

The online interviews are designed to assess applicants' willingness to go beyond an individual approach to higher education by embracing a more comprehensive one, characterized by the opportunity to experience the richness of meeting people, sharing experiences, and collaborating on projects in an international environment.

**Sensitivity to take responsibility and help**

The selection process considers the applicant's willingness to pursue personal growth by promoting social, entrepreneurial, technological, or cultural innovation and helping others.

## 1. ELIGIBLE CANDIDATES

International students enrolled in bachelor's degree programs or master's degree programs are eligible candidates. International students enrolled in doctoral or postgraduate programs should refer to the English-language Postgraduate Announcement. Applicants must be willing to integrate their university studies by committing to 70 hours per year – for bachelor's degree students – or 25 hours per year – for master's degree students – of cultural activities and soft-skills training programs to be arranged with the Residence Director. To be considered eligible, students are required to stay for at least 5 months.

## 2. AVAILABLE ACCOMMODATION

The total number of newly admitted international students in “Ferrari Dalla Spade” Residence (Via San Carlo 5 - 37129 Verona VR ) for the 2025-2026 academic year will be determined upon availability at the time of application.

## 3. SERVICES PROVIDED

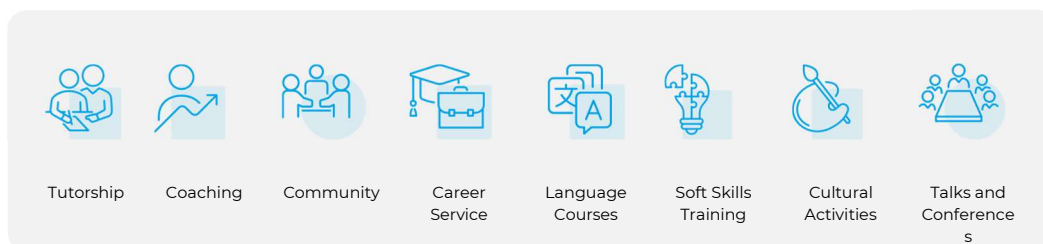
The following is an overview of the services provided:

As a College of Merit, the residential experience is designed to enhance and complement students' academic experience by developing their soft skills and preparing them for the job market through the College's training offer.

Admitted candidates will have access to all training, cultural, and career-oriented initiatives activated by the College. The offer is developed around the core values that have always characterized the Vision and Mission of Collegio Mazza: community life, attention to the person, and social impact.

All students are asked to actively participate in the residential life, each contributing according to their interests. The co-design of the College's educational program is intended to promote an approach of empowerment and *learning by doing* in an interdisciplinary context where students become active players in developing their potential.

The student community is organized into thematic groups or committees. With the support of Collegio Mazza, the community participates in planning and realizing:

- cultural events (e.g., conferences and/or trips, movie club, college blog, etc.)
- artistic, musical, or sports events (e.g., concerts, shows, college choir, reduced subscriptions for swimming pools and gyms, organization of sports competitions, hikes, etc.)
- soft skills training courses and workshops (e.g., time management, conflict management, self-awareness and emotional management, leadership, social media strategy, personal branding, etc.) and/or cultural seminars (e.g., language courses, ancient Greek, podcasting courses, debate classes, etc.).

During their stay, students will also have access to

- tutoring and academic support
- career coaching and counseling
- incentives to international mobility.

Admitted students commit themselves to defining a **Personal and Community Growth Project** (*Progetto di crescita personale e comunitaria* also known as PCPC) during the academic year – aimed at improving soft skills and pursuing self-determined growth goals – and to demonstrating interest and participation in residential life.

Students are also required to sign the **Training Agreement** (*Patto formativo*), which specifies the fulfillment established by Collegio Mazza and the Italian Ministry of University and Research (MUR) as follows

- to achieve high results in their university studies, in order to maintain, in the 2026-2027 academic year, an average mark in the exams that is higher than the average mark in the subject area of their university;
- to maintain a regular course of study, i.e. to obtain a total number of annual credits (CFUs) higher than the merit requirement set by the competent Regional Agency for the Right to Education (*Ente per il Diritto allo Studio* – ESU)
- to complete at least **70 hours of extracurricular training<sup>1</sup>** per year (approximately 7 hours per month) for bachelor's students (and first, second and third-year students of single-cycle degrees), or at least **25 hours of extracurricular training<sup>1</sup>** per year (approximately 2.5 hours per month) for master's degree students (and fourth and fifth-year students of single-cycle degrees).

At the end of the stay in the College – after a minimum stay of two academic years – it is also possible to request the issuance of a University Diploma.

<sup>1</sup> Extracurricular training hours are accredited by attending events, conferences, courses, workshops, and cultural trips proposed during the year by Collegio Mazza, the student community, and other legally recognized Colleges of Merit.



## 4. ADMISSION

**To be considered eligible candidates, students are required to stay for at least one semester (5 months).**

Admission to Collegio Mazza is contingent upon the successful completion of a preliminary selection process, followed by an online group interview.

Applications for the **entire academic year** or at least **one semester (5 months)** must be submitted by registering on the platform, entering the requested data, and properly submitting the required documentation. **Submit the complete application** to <https://applications.collegiomazza.it/auth/login> by the following deadlines:

### 4.1 ONLINE APPLICATION

When applying, the following information is required:



- biographical and family information
- school or academic background information
- self-introduction.

Applicants must fill out the **form with** their **personal data**, i.e., name, date and place of birth, nationality, home address, phone number, and email address, and answer some **self-introduction questions**.

The application requires the **upload of the following documents**:

- a copy of the ID card or passport
- digital photo (close-up)
- curriculum vitae
- certificate of enrollment (or pre-enrollment procedure) in the Italian university
- transcript of records (bachelor's and master's degree students) and degree certificate (master's degree students only)
- study plan (first-year students excluded)
- diploma supplement (if necessary it will be requested by the admission staff).

#### 4.2 ONLINE INTERVIEW WITH THE DIRECTOR'S OFFICE



Once the application has been submitted and all documents have been uploaded, applicants will be contacted by Collegio Mazza via their e-mail address and invited to attend the first available session for **an online interview with the Director's Office**. Upon request, this interview may take place in person.

In this phase, the following aspects will be evaluated: an overall evaluation of the candidate, with particular attention to the candidate's readiness and aptitude for the experience offered by the College or the presence of socio-economic or family need conditions; the candidate's academic background and qualifications, curricular and extracurricular experiences; communication skills; experience abroad; proactivity and resourcefulness; the affinity of the candidate's profile with the college context; their motivation and interest in the training offer and community life of Collegio Mazza.



##### Online application and CV

In this phase, the following aspects will be evaluated: experiences, hobbies and motivation in line with the offer of Collegio Mazza (e.g. aptitude for relationships, personal growth, innovation skills, community life).

Max **10** points



##### Interview with the Director's Office

In this phase, the following aspects will be evaluated: the candidate's academic background and qualifications, curricular and extracurricular experiences; communication skills; experience abroad; proactivity and resourcefulness; the affinity of the candidate's profile with the college context; their motivation and interest in the training offer and community life of Collegio Mazza.

Max **30** points

#### 4.3 ONLINE INTERVIEW WITH AN EXTERNAL EXAMINATOR



This phase is aimed at specifically assessing the project letter that identifies suitability to the context and community dynamics characterizing the life of the Residences.

#### Applications will be accepted from 15 May 2026.

## 5. OUTCOME OF THE APPLICATION

The admission ranking will be based on the score obtained from the assessment of two elements. Specifically, the following will be considered for ranking purposes

<b>SESSION</b>	Online application and CV	Max <b>10 points</b>
	Online interview with the Director's Office	Max <b>30 points</b>
	Online interview with an external examiner	Max <b>30 points</b>

To be **considered for admission**, candidates must achieve a **minimum score of 55/70**. This score is the sum of the scores obtained in the above-mentioned assessment sections.

The number of candidates admitted at the end of each session is unquestionably determined by the Director's Office based on the available places and the outcome of the application process.

As stated in the opening of this call, and in accordance with the nature of our institution, the economic and family situation of the candidates will be taken into consideration in the evaluation process. Particular attention will be paid to situations of real need.

The Director's Office will announce the outcome of admission via email within seven days of the conclusion of the admission process.

## 6. ACCEPTANCE OF THE PLACE

Following the notice of admission, the secretariat of the residence will send the contract documents to the admitted student.

Admission is considered **confirmed only upon receipt of the signed documentation within five business days**. This must be accompanied by **payment (€350.00) of the mandatory deposit**. Proof of payment must be provided as well.

## 7. FEE

Admitted – bachelor's and master's degree students – students have access to the accommodation facility and the training activities organized by Collegio Mazza on favorable terms, thanks to the economic contribution of the Italian Ministry of University and Research (MUR).

The accommodation services may vary according to the student's requests. The following rates apply:

<b>ACCOMMODATION</b> (single/double room with en-suite bathroom)	<b>€450.00</b> per month
<b>ADDITIONAL SERVICES</b> (1 meal per day, dinner from Monday to Friday)	+ <b>€180.00</b> per month

At its sole discretion, the college administration may offer economic benefits to students in particular situations and/or with specific needs. To apply for these benefits, students must submit the *ISEE parificato* and a letter of reference and presentation from an Italian or international association, institution, or body in the field of international cooperation, humanitarian aid, and/or advocacy for the right to study. The letter must outline the financial situation of the student and their family. Students must also provide contact information of professionals working within the said organization who are familiar with the student's situation.

Should the applicant fail to honor the commitment to participate in the training activities as referred to in point 1 of this call, the fee will be increased by €150.00 per month.

## **8. VERIFICATION OF THE TRUTHFULNESS OF STATEMENTS**

Collegio Mazza will carefully and thoroughly check the veracity of the statements made by the applicant, as well as their academic performance. Should the content of the statements be deemed to be untruthful, the student will forfeit the benefits on offer. Please be aware that making false statements is punishable under the Italian Penal Code and special legislation (i.e., articles 75 and 76 of the Presidential Decree No. 445, 28 December 2000).

## **9. REGULAR AND EXTRAORDINARY SESSIONS**

The Director's Office may schedule additional extraordinary sessions, if there are still available places in the residence, or may cancel the scheduled sessions if the available places are filled before the set deadline.

## **10. ANNUAL RENEWAL**

Admission to Collegio Mazza is intended for the academic year 2026-2027. Confirmation as a student for subsequent academic years is contingent upon an annual evaluation based on the quality of participation in community life, academic performance, and the quality of personal training in accordance with the provisions for Colleges of Merit detailed by the Italian Ministry of the University and Research (MUR).

## **11. INCLUSIVE ENVIRONMENT**

The College is dedicated to fostering an inclusive environment for all members of the community. To this end, it is committed to removing cultural, relational, bureaucratic-administrative, physical, and architectural barriers that may hinder a sense of belonging, active participation, and responsible leadership among those who live the residential and training experience in the College's various residences. Inclusivity is based on the personalization of relationships in the phases of reception, insertion, and permanence of the student. It is also based on continuous listening fostered by frequent opportunities for meeting and exchanging knowledge between the Directors' Office and students. With this in mind, applicants are encouraged to report any special needs or situations during the application process.
